A BILL

To reauthorize the Federal Land Transaction Facilitation Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “FLTFA Reauthoriza-
5 tion Act”.

6 **SEC. 2. REAUTHORIZATION OF THE FEDERAL LAND TRANS-**
7 **ACTION FACILITATION ACT.**

8 The Federal Land Transaction Facilitation Act (43
9 U.S.C. 2301 et seq.) is amended—

1 (1) in section 203(2) (43 U.S.C. 2302(2)), in
2 the matter preceding subparagraph (A), by striking
3 “on the date of enactment of this Act was” and in-
4 serting “is”;

5 (2) in section 205 (43 U.S.C. 2304)—

6 (A) in subsection (a), by striking “(as in
7 effect on the date of enactment of this Act)”;
8 and

9 (B) by striking subsection (d);

10 (3) in section 206 (43 U.S.C. 2305), by striking
11 subsection (f); and

12 (4) in section 207(b) (43 U.S.C. 2306(b))—

13 (A) in paragraph (1)—

14 (i) by striking “96–568” and insert-
15 ing “96–586”; and

16 (ii) by striking “or” at the end;

17 (B) in paragraph (2)—

18 (i) by inserting “Public Law 105–
19 263;” before “112 Stat.”; and

20 (ii) by striking the period at the end
21 and inserting a semicolon; and

22 (C) by adding at the end the following:

23 “(3) the White Pine County Conservation,
24 Recreation, and Development Act of 2006 (Public
25 Law 109–432; 120 Stat. 3028);

1 “(4) the Lincoln County Conservation, Recre-
2 ation, and Development Act of 2004 (Public Law
3 108–424; 118 Stat. 2403);

4 “(5) subtitle F of title I of the Omnibus Public
5 Land Management Act of 2009 (Public Law 111–
6 11; 123 Stat. 1032);

7 “(6) subtitle O of title I of the Omnibus Public
8 Land Management Act of 2009 (Public Law 111–
9 11; 123 Stat. 1075);

10 “(7) section 2601 of the Omnibus Public Land
11 Management Act of 2009 (Public Law 111–11; 123
12 Stat. 1108); or

13 “(8) section 2606 of the Omnibus Public Land
14 Management Act of 2009 (Public Law 111–11; 123
15 Stat. 1121).”.
